Sierra Pacific also undergoes regular third-party product testing and inspections of our manufacturing facilities to ensure our conformance for certification through the Window and Door Manufacturer's Association (WDMA) Hallmark Program. The Hallmark Program is considered a mark of excellence among Architects, Specifiers and Contractors industry-wide.

Our products are also certified through the National Fenestration Rating Council (NFRC) for energy performance and Sierra Pacific is an Energy Star Partner.



The **Window & Door Manufacturers Association** (WDMA) Hallmark Certification Program provides a method of identifying windows and doors that are manufactured in accordance with AAMA/WDMA/CSA 101/I.S.2/A440 standards. Regular third party product testing and inspection of manufacturing facilities ensures conformance. Certification through the WDMA Hallmark Program is highly regarded by architects, contractors and government agencies.
